What is 4-H Camp?

Allen County 4-H camp is held annually at Camp Palmer. Camp Palmer is 150 acres of woods, streams and fields. Programs include swimming, canoeing, indoor/outdoor recreation, nature hikes, and sports of all sorts, crafts and fishing. 4-H Camp is five days spent with friends while learning new skills and having fun!

Campers stay in cabins with fully trained American Camper Association certified teens from Allen County. Adult staff as well as permanent staff and extension staff provide support to programming. The camp is also staffed with a nurse and emergency medical staff is on call at all times.

Registration Information

4-H Camp is open to youth ages 9-15. Please contact the office if you have questions about your child and their ability to register for camp.

Camp fee for 2019 is \$185.00. The registration deadline is Friday, June 14th.

Camp fee includes lodging, 3 meals + 1 snack per day, all activities (except challenge course & shooting sports), camp insurance and a camp T-shirt.

There will be no refunds for camp after June 29th, 2019.

Optional Costs

Challenge by Choice (High Ropes) \$20.00 Extra

The experience of a lifetime! Team building and high elements activities are meant to build community and empower groups and individuals to interpersonal development and personal growth. The final phase is an adventure 20 feet off the ground with the High Aerial Challenge Course. In order to participate 4-H'ers must be able to reach 6 feet 2 inches and be at least 11 years old. Participation is limited to twelve (12) participants and will be taken on a first return basis.

Shooting Sports \$10.00 Extra

Campers will spend a jam packed morning or out-posting session depending on the specialty being introduced to rifle, shotgun (ages 10 and up), or archery. Youth will practice safety, response to range commands, learn basic shooting fundamentals, clean and maintain equipment, learn about eye and ear protection, develop shooting skills, explore conservation issues and compete in shoots. Club advisors are certified through the Ohio 4-H Shooting Sports program and also through the county volunteer program. In case of inclement weather we may need to issue a refund for sessions purchased.

Members can also bring money to be deposited into a "Bank" for buying pop, snacks, t-shirts, and or other items from the Camp Palmer store. We are NOT responsible for money not deposited into the Bank at Camp.
